I hereby register to rent a sailboat from the LEWES YACHT CLUB and agree to pay for all damages or loss of parts beyond normal wear. Normal wear is considered to be minor scratches and scrapes that result during normal usage. Normal wear does not include: (1) Ripped sail (2) Bent or broken spars, (3) holes or cracks in the hulls, (4) lost daggerboard or lifejackets, (5) Broken, cracked or lost tillers or tiller extensions, rudders, or tiller connecting bars.

I agree that I rent this boat at my own risk and that I am fully responsible for ALL OTHERS who use this boat while rented to me.

I hereby release LEWES YACHT CLUB, ITS OFFICERS, DIRECTORS, MEMBERS AND EMPLOYEES (herein after referred to, for convenience, as LYC) from any cause of action, claim, demand or right, in contract, tort, or otherwise which I or the children in my custody for whom I sign, may now or hereafter have, based upon, arising from or due directly or indirectly to injury to the person, including loss of life, or loss or damage to the property of any or all the persons whose names appear below, including myself, regardless of where such injury occurs...that is, whether upon the land premises of LYC or upon the waters of Delaware or elsewhere.

I further agree to indemnify and hold harmless LYC against any liability, loss, damage or expense which may be incurred by LYC by reason of the assertion of any cause, claim, demand or right against LYC by any person of the nature referred and described above while this rental is registered in my name.

The consideration for the granting of this RELEASE and undertaking to INDEMNIFY LYC is, in addition to other good and valuable considerations, the undertaking of LYC to permit those whose names below to enter upon the premises of the LEWES YACHT CLUB and to make use of its sailing facilities and equipment, including sailboats.
